Privacy Policy

Please read this policy before providing personal information and using our Sites. By using our Sites you are agreeing to the terms laid out in our Privacy Policy.

This Privacy Policy provides you with information regarding the type of personal information Sawatzky Equine Services (also referred to as 'Sawatzky Equine', 'we' or 'us') collects, uses and discloses. You will also be informed about the choices you have in the use and disclosure of your information and how you may change or update your information. All information collected by us will be subject to our current Privacy Policy unless your consent has been given to treat it in a different manner. Our Privacy Applies to all personal information collected or received through our online platforms and websites (collectively known as 'Sites').

Collection of Personal Information

This Privacy Policy applies to the collection, disclosure and use of your personal information by Sawatzky Equine Services.

Your personal information is any data (factual or subjective) about an individual person or identifies an individual. Examples of this data include (but are not limited to); name, email address, mailing address, and/or information regarding your horse. Personal information does not include information used to only to communicate with your regarding employment, business or profession.

We collect personal information when you sign up for an event, opt-in to receive emails, participate in surveys, sign a waiver at our facility or apply for one of our programs. We also collect your information through the use of third party service providers. We only knowingly collect a child's personal information with parental/guardian consent.

Use of technology to collect data

We use "cookies" on our Sites. If you would prefer to opt out of the use of "cookies" please change the settings regarding cookies in your browser or do not use our Sites.

Use of Personal Information

The purpose of collecting your information will be stated or implied and we will gain your consent before collection. We collect personal information for a number of reasons such as; sending promotional materials, registration for events, use of our facility and internal business purposes. We may also use your information as required by law. Your consent is collected when you provide your information to us. We strive to make your consent visible and provide options to opt-out.

Disclosure of Personal Information

Generally, we do not disclose personal information unless required by law. In the event your personal information is disclosed we will gain your consent before disclosure. Aside from disclosures, we use service providers to aid us in business operations.
